Kansai University Review of Business and Commerce Submission Rules

Published September 25, 2019

(Purpose)

Article 1. These rules govern matters relating to submissions to the academic journal *Kansai University Review of Business and Commerce* (hereafter referred to as “*The Review*”), published by the Kansai University Faculty of Business and Commerce.

(Publication and manuscript deadline)

Article 2. *The Review* is published annually in principle, in March. The deadline for submission of manuscripts is five months before the publication.

(Qualifying submissions)

Article 3. Manuscripts that qualify for submission to *The Review* are, in principle, those written by full-time faculty members of the Kansai University Faculty of Business and Commerce. However, non-full-time faculty members may also publish in *The Review* if there is a recommendation from a full-time faculty member of the Kansai University Faculty of Business and Commerce and the publication is approved by the editorial board.

(Submission requirements)

Article 4. The author must comply with the Kansai University Research Ethics Standards.

(Copyright)

Article 5. The copyright of the manuscripts published in *The Review* belongs to the author. However, digital reproduction rights for secondary use shall be granted by the author to the editorial board at the time of publication.

(Permission to reprint translations)

Article 6. The author can translate and publish articles in *The Review* that have already been published in other journals. However, the author must obtain permission to translate and reprint from the journal / publication in which the paper originally appeared, and must disclose this to *The Review*.

(Miscellaneous provisions)

Article 7. In addition to the points stipulated in these regulations, style and other requirements shall be provided separately.

(Supplementary provision)

These rules came into effect on September 2019.
